Brick Municipal Races 2023:

Proceeds will benefit CTE John Catalano, CTE Mary Jonas Buckley, CTE James Palmisano, CTE Rocco Palmieri, and/or CTE Theresa Gallagher. New Jersey law prohibits entities operating in certain regulated industries (financial institutions, insurance companies, utilities) from contributing. Election Law allows contributions with a limit of \$2,600 per candidate, per election cycle from individuals and corporations and \$8,200 per candidate, per election from PAC's.

A partnership or limited liability company may not contribute as an entity. However, a check from a partnership or limited liability company may be accepted so long as it is accompanied by a letter allocating the contribution to the individual partner(s) or member(s) and is signed by each contributing partner or member. The letter must include each contributing partner's home address. A partner's total contribution, through the partnership and personally, cannot exceed the \$2,600 per candidate, per election cycle limit.

The Executive Order of Governor McGreevey concerning campaign contributions that took effect October 15, 2004 and the Executive Order of Governor Corzine that took effect November 15, 2008 does not affect contributions given to the candidate accounts listed above. The restrictions in the Governors' orders apply to State and County Party Political Committees (Republican and Democrat). Therefore, if you have a contract with the State of New Jersey over \$17,500 after 10/15/04, you may still contribute to any of the candidate accounts listed above.

Restoring America's Mission PAC (RAM PAC):

New Jersey election law allows contributions with a limit of \$7,200 annually from individuals, PAC's and corporations, except from those industries regulated by the State of New Jersey. A partnership may contribute the maximum of \$7,200 per partner annually. A letter allocating the contribution to the individual partner(s) must accompany the check. The letter must include each contributing partner's address. A partner's total contribution, through the partnership and personally, cannot exceed the \$7,200 annual limit.

Contributions to RAM PAC are not prohibited by Executive Order #134. RAM PAC is a Political Action Committees that raises funds to help candidates through direct funding or campaign assistance. The PAC does not contribute to the State Committee, County Committee or Municipal Committee accounts, which are impacted by Executive Order #134. Donating to RAM PAC does not ban you from receiving State contracts.

Political contributions are not deductible for income tax purposes.
