The Ocean County Republican Finance Committee, Inc:

Please be advised that Executive Order #134 (effective October 15, 2004) applies to contributions to the Ocean County Republican Finance Committee (OCRFC). Vendors doing or seeking to do business with the State of New Jersey may be prohibited (including owners of 10% or more of assets or profits). In compliance with the Executive Order, the OCRFC can accept contributions up to \$300 from individuals and corporations. Please see Executive Order 134 for further information.

New Jersey election law allows contributions with a limit of \$37,000 annually from individuals, PAC's and corporations, except from those industries regulated by the State of New Jersey. A partnership may contribute the maximum of \$37,000 per partner annually. A letter allocating the contribution to the individual partner(s) must accompany the check. The letter must include each contributing partner's address. A partner's total contribution, through the partnership and personally, cannot exceed the \$37,000 annual limit.

New Jersey election law requires we collect the name, address, employer, employer's address and occupation for every individual whose aggregate contributions exceed \$300 in a calendar year.

Sadeghi for Commissioner & Committee to Re-Elect Surrogate Jeff Moran:

Proceeds will benefit Sadeghi for Commissioner and/or Committee to Re-Elect Surrogate Jeff Moran. New Jersey law prohibits entities operating in certain regulated industries (financial institutions, insurance companies, utilities) from contributing. Election Law allows contributions with a limit of \$2,600 per candidate, per election cycle from individuals and corporations and \$8,200 per candidate, per election from PAC's.

A partnership or limited liability company may not contribute as an entity. However, a check from a partnership or limited liability company may be accepted so long as it is accompanied by a letter allocating the contribution to the individual partner(s) or member(s) and is signed by each contributing partner or member. The letter must include each contributing partner's home address. A partner's total contribution, through the partnership and personally, cannot exceed the \$2,600 per candidate, per election cycle limit.

The Executive Order of Governor McGreevey concerning campaign contributions that took effect October 15, 2004 and the Executive Order of Governor Corzine that took effect November 15, 2008 does not affect contributions given to Sadeghi for Commissioner or the Committee to Re-Elect Surrogate Jeff Moran. The restrictions in the Governors' orders apply to State and County Party Political Committees (Republican and Democrat). Therefore, if you have a contract with the State of New Jersey over \$17,500 after 10/15/04, you may still contribute to Sadeghi for Commissioner and the Committee to Re-Elect Surrogate Jeff Moran.

Contributions are not deductible for income tax purposes.
