Ocean County Republican Finance Committee:

Proceeds will benefit the New Jersey Republican State Committee. New Jersey law prohibits entities operating in certain regulated industries (casinos, financial institutions, insurance companies, utilities) from contributing. Election Law allows contributions with a limit of \$75,000 annually from individuals, PACs and corporations.

A partnership or limited liability company may not contribute as an entity. However, a check from a partnership or limited liability company may be accepted so long as it is accompanied by a letter allocating the contribution to the individual partner(s) or member(s) and is signed by each contributing partner or member. The letter must include each contributing partner's or member's home address.

The Ocean County Republican Chairman's PAC

New Jersey election law allows contributions with a limit of \$14,400 annually from individuals, PAC's and corporations, except from those industries regulated by the State of New Jersey. A partnership may contribute the maximum of \$14,400 per partner annually. A letter allocating the contribution to the individual partner(s) must accompany the check. The letter must include each contributing partner's address. A partner's total contribution, through the partnership and personally, cannot exceed the \$14,400 annual limit.

**Contributions to any of the accounts listed above are not deductible for income tax purposes.
Contributions over \$200 are reportable with NJ ELEC.**
