The Committee to Re-Elect Mayor John Peterson, Jr.:

Proceeds will benefit the Committee to Re-Elect Mayor John Peterson, Jr. New Jersey law prohibits entities operating in certain regulated industries (financial institutions, insurance companies, utilities) from contributing. Election Law allows contributions with a limit of \$2,600 per election cycle from individuals and corporations and \$8,200 per election from PAC's.

A partnership or limited liability company may not contribute as an entity. However, a check from a partnership or limited liability company may be accepted so long as it is accompanied by a letter allocating the contribution to the individual partner(s) or member(s) and is signed by each contributing partner or member. The letter must include each contributing partner's home address. A partner's total contribution, through the partnership and personally, cannot exceed the \$2,600 per election cycle limit.

The Executive Order of Governor McGreevey concerning campaign contributions that took effect October 15, 2004 and the Executive Order of Governor Corzine that took effect November 15, 2008 does not affect contributions given to the Committee to Re-Elect Mayor John Peterson, Jr.. The restrictions in the Governors' orders apply to State and County Party Political Committees (Republican and Democrat). Therefore, if you have a contract with the State of New Jersey over \$17,500 after 10/15/04, you may still contribute to the Committee to Re-Elect Mayor John Peterson, Jr.

Contributions are not deductible for income tax purposes.
