A partnership may contribute the maximum of \$14,400 per partner annually. A letter allocating the contribution to the individual partner(s) must accompany the check. The letter must include each contributing partner's address. A partner's total contribution, through the partnership and personally, cannot exceed the \$14,400 annual limit. Contributions to any entities listed above are not deductible for income tax purposes. Contributions over \$200 are reportable with NJ ELEC.
