Contributions are not deductible as charitable donations for federal income tax purposes. All contributions are subject to the limitations of the Federal Election Campaign Act. Only personal and PAC checks or personal and PAC credit cards are acceptable. An individual may contribute up to \$3,300 for the Primary Debt 2024 Election, and up to \$3,300 to the General 2024 Election. Multicandidate PACS may contribute \$5,000 per election and non-multicandidate federal PACS may contribute \$3,300 per election. Contributions from corporations, foreign nationals, and federal government contractors are prohibited. Contributions must be made from personal or PAC funds and may not be reimbursed by any other person or entity.

Information for Partnerships or LLC's: A partnership or limited liability company may not contribute as an entity. However, a check from a partnership or limited liability company of up to \$3,300 per election may be accepted so long as it is accompanied by a letter allocating the contribution to the individual partner(s) or member(s) and is signed by each contributing partner or member. The letter must include each contributing partners' or members' home address.

Contributions to Curtis Bashaw for U.S. Senate, Inc. are not tax deductible for federal income tax purposes
