New Jersey law prohibits entities operating in certain regulated industries (casinos, financial institutions, insurance companies, utilities) from contributing. Election Law allows contributions with a limit of \$79,000 annually from individuals, PACs and corporations.

A partnership or limited liability company may not contribute as an entity. However, a check from a partnership or limited liability company may be accepted so long as it is accompanied by a letter allocating the contribution to the individual partner(s) or member(s) and is signed by each contributing partner or member. The letter must include each contributing partner's or member's home address.

**Ocean County GOP Housekeeping:**

Proceeds will benefit the Ocean County GOP Housekeeping account \$39,500. New Jersey law prohibits entities operating in certain regulated industries (casinos, financial institutions, insurance companies, utilities) from contributing. Election Law allows contributions with a limit of \$39,500 annually from individuals, PACs and corporations.

A partnership or limited liability company may not contribute as an entity. However, a check from a partnership or limited liability company may be accepted so long as it is accompanied by a letter allocating the contribution to the individual partner(s) or member(s) and is signed by each contributing partner or member. The letter must include each contributing partner's or member's home address.

**The Ocean County Republican Chairman's PAC**

New Jersey election law allows contributions with a limit of \$15,200 annually from individuals, PAC's and corporations, except from those industries regulated by the State of New Jersey. A partnership may contribute the maximum of \$15,200 per partner annually. A letter allocating the contribution to the individual partner(s) must accompany the check. The letter must include each contributing partner's address. A partner's total contribution, through the partnership and personally, cannot exceed the \$15,200 annual limit.

**Contributions to any of the accounts listed above are not deductible for income tax purposes.  
Contributions over \$200 are reportable with NJ ELEC.**
